PURPOSE OF THE TREATMENT

CONSERVATION PERIOD

The personal data provided will be kept for the corresponding period to comply with legal obligations, or until its deletion is requested by the interested party and he is entitled to do so.

LEGITIMATION

VOLUTA ESCOLA DE MÚSICA is entitled to the processing of personal data, based on the

consent granted by the interested party for one or more specific purposes, as stated in article 6.1.a) and 6.1.b) of the General Regulation of Protection of personal data.

RECIPIENTS

They will not be transferred or communicated to other third parties, except in the cases necessary for the development, control and fulfillment of the stated purpose / s, in the cases provided by Law, as well as in the specific cases, of which expressly inform the User.

USER RIGHTS: What are your rights when you provide us with your data?

- Access: The interested party has the right to know what data the VOLUTA ESCOLA DE MÚSICA is treating about him.
- Rectification: The interested party has the right to request the rectification of inaccurate data.
- Deletion: The interested party has the right to request the deletion of their data when, among other reasons, the data is not necessary for the purposes for which it was collected.
- Limitation of treatment: In certain circumstances, the interested party may request the limitation of the processing of their data, in which case we will only keep them for the exercise or defense of claims.
- Opposition: In certain circumstances the interested party may oppose the processing of their data. In that case, VOLUTA ESCOLA DE MÚSICA will stop processing your data, except for compelling legitimate reasons or the exercise or defense of possible claims.
- Data portability: Only applicable to automated data and consists of passing the data from the VOLUTA ESCOLA DE MÚSICA to another new TREATMENT CONTROLLER (not to the interested party and at the request of the same).
